If my spouse and I die under circumstances causing uncertainty as to the order of our deaths, I direct that it shall be deemed that my spouse predeceased me for the purposes of this Will.

Article VIII – Governing Law

This Will shall be governed by and construed in accordance with the laws of the State of Delaware.
