1. Appointment

The Principal appoints the Attorney(s) named above to be the Principal's true and lawful attorney(s) to act in the Principal's name, place, and stead in all matters.

This Power of Attorney shall continue in full force and effect until revoked by the Principal in writing, notwithstanding any incapacity of the Principal.

5. Revocation

The Principal may revoke this Power of Attorney at any time by providing written notice to the Attorney(s) and any relevant third parties.

6. Reliance by Third Parties

Third parties may rely upon the authority of the Attorney(s) under this document and shall be indemnified by the Principal for any acts done in good faith reliance on this Power of Attorney.

7. Governing Law

This Power of Attorney is governed by and construed in accordance with the laws of the United States of America, and any applicable state laws.

8. Liability of Attorney(s)

The Attorney(s) shall act in good faith and with due care, but shall not be liable for losses resulting from honest mistakes or reasonable decisions made in the exercise of their authority.

9. Severability

If any provision of this Power of Attorney is held invalid or unenforceable, the remaining provisions shall remain effective.

10. Interpretation

Headings are for convenience only and shall not affect interpretation. Words importing the singular include the plural and vice versa.

11. Execution and Witnessing

The Principal has signed this document voluntarily and with full understanding of its effect. This Power of Attorney has been signed in the presence of the witness(es) whose details appear below.

12. Acknowledgment

The Principal acknowledges that they understand the nature and effect of this Power of Attorney and the powers granted herein.
