

LAST WILL AND TESTAMENT

ARTICLE I - IDENTIFICATION

ARTICLE IV - GUARDIANSHIP

If I have minor children at my death, I nominate, constitute, and appoint _____ as guardian of the person and estate of such minor children. If this person is unable or unwilling to serve, then I appoint _____ as alternate guardian.

ARTICLE V - OMISSION

I acknowledge the existence of other heirs and relatives not named herein, and any omission of any person is intentional and not due to oversight.

ARTICLE VI - TAXES AND DEBTS

I direct that all my just debts, funeral expenses, and expenses of administration be first paid from my estate, and that all taxes imposed by reason of my death be paid from my residuary estate without apportionment.

ARTICLE VII - NO CONTEST CLAUSE

If any beneficiary under this Will contests this Will or any of its provisions, any share or interest in my estate given to that contestant is revoked and shall be disposed of as if that contestant predeceased me.

ARTICLE VIII - GOVERNING LAW

This Will shall be governed by and construed in accordance with the laws of the State of Hawaii.
