This Notice is provided in compliance with all applicable United States federal and state maritime laws, including but not limited to the Welsh Maritime Lien Act, and is intended to be fully enforceable under such laws.

This Notice and any maritime lien claim arising herefrom shall be governed by and construed in accordance with the laws of the United States and the applicable maritime laws and admiralty jurisdiction thereof.
